**AUCTION NOTICE**

It is hereby informed to the intending individuals residing within the jurisdiction of **Nadia Zilla Parishad** that Vegetable retail place, Retail Shops, Huts, Hall Room, Rooms, Small Office etc. with rolling shutters at the **Chakdah (Bishnupur) Market Complex** (owned by Nadia Zilla Parishad) will be allocated among small traders for a tenure of **one (1) year** in exchange for a fixed monthly rent as determined by the **L.A. Collector, Nadia**, through a **Seal Bid Auction**. The auction will follow the schedule given below.

Upon completion of the **one (1) year** tenure, if the lessee wishes to renew, it will be granted provided that they have satisfactorily complied with all terms and conditions outlined in the agreement during the previous tenure as per the following :

- a) Timely payment of monthly rent without any arrears.
- b) The Shop/Stall/Hut/Hall Room/Rooms/Small Office has been used strictly for the purpose for which it was allocated.

Interested bidders are advised to visit the respective retail shops/ Stalls/Huts/Hall Room/Rooms/Small Offices and their locations before participating in the auction. The highest bidder in the auction will be allotted the same subject to the **terms and conditions imposed by the Nadia Zilla Parishad** and the undersigned reserves the right to accept or reject any application/bid without assigning any reason.

**General Terms and Conditions**

- 1) The applicant must be an **Indian citizen** residing in a **Gram Panchayat area** under the jurisdiction of **Nadia Zilla Parishad**. The applicant must be **above 18 years of age (as of 01-01-2025)** and must be engaged in business before participating the auction.
- 2) The applicant must submit the **duly filled application form along with :**
  - **Two (2) recent passport size photographs** (to be affixed in the specified place of the application form).
  - Self-attested photocopies of **Aadhaar Card, EPIC (Voter ID) Card, PAN Card, Trade license Certificate and Ration Card**.
  - **A demand draft of Rs. 1,000/-** payable at **Krishnagar** in favor of **F.C.&C.A.O. Nadia Zilla Parishad**.
- 3) An **Acknowledgement Slip** will be issued to the applicant upon successful submission of the application. Which will serve as a **permission letter** to participate in the auction.
- 4) A Bid paper will be issued along with the Acknowledgement Slip to the above cited successful applicant and it should be filled up and submitted in sealed envelope at the drop box, specially designated in this regard, at the office of the Nadia Zilla Parishad.
- 5) A bidder cannot submit **more than one application**. If multiple application are submitted, Otherwise, the bid will be **rejected**.
- 6) Application forms can be collected **free of cost** from the **Nadia Zilla Parishad Office** or downloaded from
- 7) If a bidder fails to meet any of the specified conditions, their bid will **rejected**.

### Post Auction Terms & Condition

- 1) Before the bidding starts on the day of the auction, **each bidder must deposit the full amount of the Security Deposit** (refundable amount) in cash to the designated officer in charge.
- 2) The entire bid amount must be deposited in the **Nadia Zilla Parishad Office** within **three (3) calendar days** from the date of auction through a **demand draft in favor of F.C.&C.A.O., Nadia Zilla Parishad** or in cash.
- 3) The allotted owner must execute an **agreement** with the **Secretary, Nadia Zilla Parishad** within **15 days** from the date of auction on a **non-judicial stamp paper worth Rs. 20/-**, purchased at the owner's expenses as per prescribed terms and conditions.
- 4) After executing the agreement, **two months' rent in advance** along with any non-refundable advance (where applicable) must be deposited before the **shop key is handed over**.
- 5) Monthly rent must be deposited at the **concerned section of Nadia Zilla Parishad** by the **7th of each month**. If rent remains unpaid for **three consecutive months**, the **Shop/Stall will be forfeited**.
- 6) Renewal after **one (1) year** is subject to **satisfactory compliance** with the previous terms and a **10% increase** in rent.
- 7) The allotted owner must **maintain the shop interior at their own expense**.
- 8) Business goods **must not be stored in verandahs, corridors, common pathways, or outside the shop perimeter**. Garbage must be deposited of properly.
- 9) **Separate electrical connection** must be obtained at the owner's expense from **WBSedcl**, and the owner must bear monthly electricity charges.
- 10) **No structural alteration** are allowed without prior written permission.
- 11) The shop **cannot be transferred or rented out** to any third party.
- 12) The owner must obtain **necessary Government licenses** at his own cost to operate the business.
- 13) Violation of **terms, illegal or anti-social activities** will result in **forfeiture of the shop/stall**.
- 14) **Periodic external maintenance** will be conducted by **Nadia Zilla Parishad**.
- 15) The **roof is not included in the auction** and **Nadia Zilla Parishad reserves the right to vertical extension**.
- 16) In case of **death or permanent disability** of the allotted owner within one year, only the **spouse/dependent child** may be allowed to continue business through fresh agreement, otherwise the **shop will be reclaimed** by Nadia Zilla Parishad.
