E-Auction process will be held only through on-line mode of bidding in the Govt e-Auction portal [<http://eauction.gov.in>].

Earnest money should be deposited in ICICI Bank, Krishnagar Branch, Account **No.193301000562, IFSC Code- ICIC0001933, in favour of FC & CAO, Nadia Zilla Parishad through RTGS/NEFT/CBS** system only. The NIA No. and/or UTR No. should be clearly mentioned on the deposit challan Payment made otherwise will be rejected.

Auction Elapse time is maximum 15(fifteen) minutes and Auction Bid auto extensions is also 15(fifteen) minutes. The e-auction shall be ascending forward online electric auction. Minimum incremental value is **Rs. 2,030/-** (Two thousand Thirty)only and maximum is 10% of base rate **i.e Rs. 10,150/-** (Ten thousand One hundred Fifty)only. The earnest money of unsuccessful bidders will be refunded to their respective bank accounts.


On successful Bidding Process the Highest Bidder will have to deposit entire Offered Rate during Tank / Pond lease agreement. Only after receiving of the entire Amount, Lease agreement will be completed by Zilla Parishad.

The Eligibility Criteria are given below: -

1. PAN Card, Voter Card [for individual only], and Registration Certificate/Trade license for Firm/Society/Company should be uploaded.
2. The bonafide Bidder should have minimum 3(three) year experience of maintaining **Tank / Pond**, Experience Certificate from Gram Panchayat/Panchayat Samity/Zilla Parishad or of any other competent authority is to be uploaded.
3. No **CONDITIONAL/INCOMPLETE** auction will be accepted under any circumstances.
4. Before issuance of the Lease Order, the Auction inviting authority may verify the documents of the highest bidder if found necessary. After verification, if it is found that such documents submitted by the highest bidder is either manufactured or false in that case, Lease Order will not be issued in favour of the highest bidder under any circumstances and auction will be treated as cancelled, as well as the Earnest Money should be forfeited in favour of the Nadia Zilla Parishad.
5. Receipt copy of deposit Earnest money should be submitted/uploaded with the tender documents.
6. All the documents in proof of their eligibility **IN ORIGINAL** need to be produced as and when asked and required.
7. An agreement will be signed between the Nadia Zilla Parishad and the successful bidder to run the tank for three years upon payment of 100% of the bid amount. Failing of any of the above conditions, it will be treated as cancellation of agreement and the Earnest Money will be forfeited.
8. Zilla Parishad will not take any liability and responsibility for any kind of accident / incident of the Tank / Pond.
9. The Nadia Zilla Parishad authority reserves the right to cancel the auction due to unavoidable circumstances.
10. The Nadia Zilla Parishad authority reserves the right to accept or reject any bid or cancel the bidding process, without assigning any reason whatsoever.
