Auction Elapse time is maximum 15(fifteen) minutes and Auction Bid auto extensions is also 15(fifteen) minutes. The e-auction shall be ascending forward online electric auction. Minimum incremental value is **Rs. 2,370/-** (Two thousand Three hundred Seventy)only and maximum is 10% of base rate **i.e Rs. 11,810/-** (Eleven thousand Eight hundred ten)only. The earnest money of unsuccessful bidders will be refunded to their respective bank accounts.

- 2. The bonafide Bidder should have minimum 3(three) year experience of maintaining Tank / Pond, Experience Certificate from Gram Panchayat/Panchayat Samity/Zilla Parishad or of any other competent authority is to be uploaded.
- 3. No CONDITIONAL/INCOMPLETE auction will be accepted under any circumstances.
- Before issuance of the Lease Order, the Auction inviting authority may verify the documents of the highest bidder if found necessary. After verification, if it is found that such documents submitted by the highest bidder is either manufactured or false in that case, Lease Order will not be issued in favour of the highest bidder under any circumstances and auction will be treated as cancelled, as well as the Earnest Money should be forfeited in favour of the Nadia Zilla Parishad.
- 5. Receipt copy of deposit Earnest money should be submitted/uploaded with the tender documents.
- 6. All the documents in proof of their eligibility IN ORIGINAL need to be produced as and when asked and required.
- 7. An agreement will be signed between the Nadia Zilla Parishad and the successful bidder to run the tank for three years upon payment of 100% of the bid amount. Failing of any of the above conditions, it will be treated as cancellation of agreement and the Earnest Money will be
